Crafters and Direct Sellers will be assigned to booths in a specific area of the sales lot. Those wishing to sell only used goods will have their own section of the lot as well. Sellers wishing to sell a mix of used goods alongside things they create by hand or by machine-assist will have a unique part of the sales lot to sell from as well.

Event Location: Inside the LARGE church parking lot, alongside West 22nd Street.

SPECIAL NOTE:

ALWAYS remember to **NOT** contact the church regarding anything to do with our Finders Keepers events! They only rent the lot from us, while providing monitored bathroom usage. They will not have **ANY** information about our events, nor will they collect and forward any contracts or booth rent fees.

Please Remember To Specify The Type Of Goods You Wish To Sell At Each Event! Your options will be: Crafted Goods - - - - - Used Goods - - - - - A Mix Of Both

For liability and safety reasons, we will record your license plates as you are checked in. That information will only be used in the event we encounter significant rules violations by individual sellers.

Booth Rental Rates

(If prepaid by the Saturday before your desired event date. If paid 6 or fewer days from your desired event date, a \$5 fee will apply per requested booth space.)

IMPORTANT = Space Dimensions: 16 Feet Wide X 19 Feet Deep

("Booth" spaces are two normal vehicle parking spaces, combined.)

Regular Booth Rental Rate = \$10 (if prepaid by the Saturday before your desired event date)
If paid on the Sunday prior to the event date or after, there is an additional \$5 fee per booth.

SPECIAL OPTIONS INCLUDE =

Endcap Spaces Rental Rate = \$20 (if prepaid by the Saturday before your desired event date)
If paid on the Sunday prior to the event date or after, there is an additional \$5 fee per endcap.

We only have 2 such spaces, located on the east end of the lot, and they have a large curved side that's all exposed to shoppers. Email us for a better explanation.

****Payments Accepted = Cash on Event Day, or in advance through Venmo**

Terms Of Agreement:

From this point forward, Trinkets-n-Treasures will be referenced as "TnT."

In accordance with the Agreement, the Vendor agrees to follow all the following terms and conditions for selling as part of this event =

**Sellers MUST report by no later than 8am but may come as early as 6am on event dates. Sellers reporting later than 8am will be turned away, and no refunds will be given.

**Sellers must move their motor vehicles to the designated vendor parking area by 8:30am. Selling will be from 9am thru 2pm

**Sellers may not move their vehicles to their sales space until "after" 2pm. Violators will be banned from future events, both Flea Market and Craft Fair.

**Unless specific exceptions are granted in advance, no sellers will be permitted to sell drinks, food, or snacks of any kind.

Rainchecks will be offered in case weather conditions postpone or cancel an event date. However, those rainchecks MUST be used during our 2026 season, and **CANNOT be refunded.

****NO REFUNDS WILL BE OFFERED!** Once payments are made for specific event dates, we are not able to issue refunds for ANY reason!

**Vendor clearly understands that they are restricted to use only the space TnT's event organizer(s) allot to them. If they need more space, they must request, be granted for, and pay for additional space. TnT reserves the right to deny such a request for additional space for any reason. Vendors may NOT "bleed over" into areas outside their spaces, unless their vendor neighbors permit it.

**TnT nor its organizers shall be responsible for any shortages, loss, theft, or damage while the merchandise is on the property during this event. The vendor accepts all losses due to these circumstances.

**TnT reserves the exclusive rights to determine what is and is not sold. By extension, TnT reserves the right to demand the removal of any merchandise deemed unacceptable/inappropriate for sale during this event, for any reason. TnT also reserves the right to adjust the Vendor's display if it presents a safety hazard or where we deem appropriate, as per our contract with the city.

**Vendor will be permitted to share their space with another Vendor, but only with expressed permission of TnT in advance of setting up for that event. Should a Vendor wish to share their space with a partner or business, it is the vendor's responsibility to inform their partner(s) of all agreement specifics of this agreement. That includes ensuring that their partner(s) is/are also bound to all agreements made herein.

**Vendor agrees to waive and relinquish all claims they may have against TnT, and any agents thereof, as a result of their participation in this event and that they share and display their products and services at their own risk.

**Vendor expressly agrees to indemnify and hold harmless TnT and its agents from any and all claims, damages, liability, or court awards, including, costs and attorney's fees, that are or may be awarded as a result of any loss injury, or damage sustained or claimed to have been sustained by anyone. This includes but is not limited to, any person, firm, partnership, or corporation, in connection with or arising out of any omission or act of commission by Contractor or any of its employees or agents in performing work pursuant to the Agreement or arising out of, connected with, or in any way associated with the activities of the Vendor sales.

Parking: Vendors will be required to park their motorized vehicles along the western edge of the sales lot. No vendor parking is available along West 22nd Street or in the smaller church parking lot. This rule also includes friends and family assisting the vendor with sales. "Finders Keepers" event staff will help guide vendors to the designated vendor parking area. **THE EXCEPTION WILL BE THE FLEA MARKET ONLY SELLERS WHO WILL BE ASSIGNED SPACES ALONG THE NORTHERN EDGE OF THE SALES LOT!

**This Agreement shall be constructed and governed in accordance with the laws of the State of Colorado.

I agree that all the demonstrations and exhibits may be photographed for publicity purposes.

Please complete the designated area on the first page of this document and then sign it on this page either electronically or with wet ink. If by wet ink, **take CLEAR and Legible pictures of all 3 pages**, and email them to us by using the email address below. You can also bring in your wet ink contract in person during the vendor check-in period.

WARNING FOR THOSE BRINGING THEIR WET INK CONTRACTS TO THE EVENT!!!

We will **NOT** have paper copies of the contract available on event dates. And we also cannot allow you on the lot without turning in a **FULL** signed contract (we cannot accept just one or two pages - - it must be the **FULL** 3-page document). If you “forget” to bring your contract, and you’ve already paid in advance, we will need to turn you away and you will not be refunded.
